CONTRACT TERMS AND CONDITIONS

1. Scope

Present conditions apply to the services supplied by CRP Henri Tudor and described in this contract. They prevail over any other terms and conditions and in particular over any general conditions of purchase of the Sponsor. No other text can prevail without a written contract, signed by an authorized representative of CRP Henri Tudor.

2. Effectiveness and duration

This contract shall not be effective until countersigned by CRP Henri Tudor. CRP Henri Tudor reserves the right to reject any application in its sole and absolute discretion.

This contract shall end upon complete discharge of CRP Henri Tudor and Sponsor's obligations.

3. Payment terms

Entire payment is due upon receipt by the Sponsor of contract, duly countersigned by CRP Henri Tudor.

The amount paid by the Sponsor will be reimbursed by CRP Henri Tudor to the Sponsor in case of cancellation of the conference by CRP Henri Tudor, regardless of the reason for cancelling.

4. Warranty

The CRP Henri Tudor undertakes that it will perform the services with due care in accordance with the state of the art practices for the relevant services being provided.

5. Intellectual property

The Sponsor hereby expressly grants the CRP Henri Tudor any and all intellectual property rights or licenses necessary for proper performance of the contract (including, but not limited to, the right to copy and display the Sponsor's logo on the conference poster, website, proceedings and related documents, as well as the right to place on the conference website a link to the Sponsor's homepage).

6. Limitation of liability

CRP Henri Tudor shall have no liability for any failure to perform its obligations hereunder where such failure to perform was due to any riot, strike, civil disorder, act of God or any other cause of any case whatsoever not within CRP Henri Tudor's reasonable control. Under no circumstances shall CRP Henri Tudor have any liability for lost profits or other special, incidental or consequential damages and CRP Henri Tudor total liability hereunder shall in no case exceed the amount of the total sponsoring amount actually received by CRP Henri Tudor.

7. Insurance
